A proposal for a Bill to incorporate the human right to food into Scots Law The consultation runs from 24 June to 15 September 2020. As a Foodbank we are at the frontline of taking practical action to reduce food insecurity in our community. We consider it unacceptable that in 21st century Scotland anyone has to rely on charity to get the food they need to live. We long for the day when our Foodbank can close its doors as we are no longer required.

As a result, we welcome initiatives such as this bill to give priority at a national level to addressing food insecurity. The right to food is such a basic human right – if someone does not have the food to live, what value are the other rights we hear so much about? Although we are unsure of how the right will work in practice, we welcome it becoming enshrined in Scots law and so being given the prominence it deserves. As members of the Independent Food Aid Network we are supportive of the Network's Cash First Project aimed at improving access to cash-based options for those experiencing food insecurity.
